A gift in your will
can provide a lifeline for
India's street children



Friends of SBT supports Salaam Baalak Trust to get vulnerable children off the street and on their feet through the provision of safe shelter, healthcare, nutritious food, education and access to support.

Funds we raise in the UK are spent:

- Providing 24 hour residential care for up to 400 children aged 4-18 years at any given time, through the running and staffing of seven residential care homes in Delhi.
- In the provision of 10 day-care centres, known locally as Contact Points, for non-residential, vulnerable children who need support.
- Enabling 3 emergency childline telephone helplines to provide help for 1200-1500 children and young people every year.

In doing this, we aim to encourage a sense of safety, self-worth, confidence and rounded social development for as many vulnerable children in dangerous and precarious situations as possible.

You may have spent time in India and have witnessed the brutally hard life street children there have. Perhaps you've been inspired by the City Walk in the streets of Delhi, or through a volunteering experience.

Whatever your reason for wanting to make a change to the lives of the children supported by Salaam Baalak Trust, leaving a gift in your Will through Friends of SBT will make a last difference.

We recommend you use a solicitor or professional Will writer to have your Will drafted. You can inform your solicitor or professional Will writer that you would like to leave a gift to Friends of Salaam Baalak Trust and they will help you to include it in your wishes. The document is intended as a guide only.

What type of gift can I leave?

There are two main ways of leaving a gift in your Will. A pecuniary legacy (also known as a cash gift) is a fixed amount of money, while a residuary legacy (also known as a share in your estate) is a percentage or share of the balance of your estate, once all other payments and gifts have been made. Many supporters choose to leave a residual gift as it keeps in line with inflation and doesn't lose value over time.

Are there any tax benefits if I leave a charitable gift in my Will?

Most charitable gifts are exempt from Inheritance Tax, and they can even reduce the amount of tax your estate has to pay. To find out more, visit HMRC on gov.uk/inheritance-tax or ask your solicitor.

If you would like to leave a gift in your Will to Friends of Salaam Baalak Trust, here is some suggested wording that you may want to use to ensure your wishes are carried out:

To leave a share of your estate

"I give to Friends of Salaam Baalak Trust UK, of registered address: Lamp Cottage, The Street, East Clandon, Surrey GU4 7RY United Kingdom , registered charity number: 1134990 [all/_% of the residue] of my estate absolutely for its general purposes and I declare that the receipt of the Trustees or other proper officer at Friends of Salaam Baalak Trust for the time being shall be a sufficient discharge to my executor(s)."

To leave a cash gift

"I give to Friends of Salaam Baalak Trust UK, of registered address: Lamp Cottage, The Street, East Clandon, Surrey GU4 7RY United Kingdom , registered charity number: 1134990 the sum of [specify words and figures] free of tax for its general purposes and I declare that the receipt of the Trustees or other proper officer at FoSBT for the time being shall be a sufficient discharge to my executor(s)."
